Rhona Flin
PhD, FBPsS, FRSE

Rhona Flin (PhD, FBPsS, FRSE) is Professor of Industrial Psychology, Aberdeen Business School, Robert Gordon University and Emeritus Professor of Applied Psychology, University of Aberdeen. Her work examines human performance in high risk work settings, such as healthcare, aviation and the energy industries, with studies focusing on leadership, safety culture, team skills and cognitive skills. In recognition of her research, she has been awarded Fellowships by the Royal College of Surgeons of Edinburgh, the Royal College of Physicians and Surgeons of Glasgow and the Royal Aeronautical Society.

Current projects include product safety culture, managers' safety leadership and non-technical skills in safety-critical tasks. Her books include *Safety at the Sharp End: A Guide to Non-Technical Skills* (2008, with O'Connor & Crichton) and *Enhancing Surgical Performance: A Primer on Non-Technical Skills* (2015, with Yule and Youngson).

Peter Bennett is managing director of PASMA, the not-for-profit organisation representing the international mobile access tower industry, executive director of the Ladder Association, and chair of the Access Industry Forum (AIF), the forum for the principal trade associations and federations involved in work at height and height safety.

Peter sits on a number of UK and international safety-related committees and is chair of the trustees of the No Falls Foundation, a registered UK charity dedicated to preventing falls from height and helping people affected by the life-changing consequences of a fall. Peter was instrumental in establishing the All Party Parliamentary Group (APPG) on Working at Height which is currently investigating serious injuries and fatalities while working at height.

Paul Roberts BA, CMIOSH, Dip ESM, Dip RSA, BSI Lead Auditor is the Guildhall Health and Safety Manager for the City of London Corporation. The Guildhall Great Hall has been the centre of City government since the Middle Ages. It is Grade 1 Listed and is the City's only surviving secular medieval building dating from 1411.

Paul is responsible for the Safety of over 1500 people working within the Guildhall Complex ranging from office Space, Art Gallery, Business Library, Police Museum and the City of London Police Headquarters.

The Guildhall also holds approximately 600 events throughout the year ranging from State Dinners, Commonwealth Heads of State conference, Lord Mayors Show, The Booker prize, to private industry/entertainment related events. Paul also manages the H&S for all these events and has been a regular member and contributor to SAGE-Safety Advisors Group in Entertainment and various other Health and Safety Groups.



David Thomas

David is a chartered civil engineer and a chartered safety and health practitioner, with experience in civil engineering design and management, enforcement, contracting and manufacturing.

Nearly ten years of his career was spent at the Health and Safety Executive, latterly as a Principal Specialist Inspector (Construction). He was technical advisor to the falls from height programme; contributed to national and international standards; and managed a large portfolio of work at height-related research.

Now a director of the Temporary Works Forum, he provides independent advice through Heightsayfe Ltd. He is the Health, Safety and Technical Advisor to IRATA International (and an individual life member) and chairman of BSI Technical Committee PH/5, Personal fall protection.

THE VENUE

London Guildhall

Steeped in tradition, Guildhall invites guests on a journey spanning more than 800 years - from the Gothic grandeur of the Great Hall to the largest surviving medieval crypts in London. Home to the City of London Corporation, Guildhall is a remarkable backdrop to national celebrations, corporate entertainment and major conferences. Seven flexible function spaces offer unique settings for large and small scale events, daytime or evening, right at the heart of the City.

Guildhall hosts many events throughout the year, the most notable one being the Lord Mayor's Banquet, which is held in honour of the immediate-past Lord Mayor and is the first to be hosted by the new Lord Mayor of the City of London. In keeping with tradition, it is at this Banquet that the Prime Minister makes a major World Affairs speech. One of the last acts of the outgoing Lord Mayor is to present prizes at the City of London School prize day at Guildhall. Other events include those of various law firms, award evenings for the Wine and Spirit Education Trust (WSET), and the banquet for the International Wine and Spirit Competition (IWSC).

Situated directly beneath the Old Library, the Livery Hall shares many of its fine Victorian Gothic features. Designed by Sir Horace Jones in 1872, the Grade II listed Livery Hall was used as a museum until the outbreak of the Second World War. The contents were removed for safe-keeping but were never returned, later being transferred to the Museum of London. Restored as an events space and reopened in 2008, the room was renamed the Livery Hall to reflect the City of London's Livery ties. Coloured lighting beautifully illuminates the architecture, and a purpose-built kitchen, servery, lift and cloakroom facilities immediately adjoin the room.


